

Kathy Asbell, Wakulla County Refuge House, was the first guest speaker and began by sharing some alarming statistics about domestic violence.

Nicky Yarborough, founder of Life in the Now Ministries, followed with a dynamic and encouraging message highlighting her personal experience as a domestic violence victim. Through her struggles, Ms. Yarborough conceptualized and drew upon what she calls "Now Faith", which means that we should recognize the past, learn from the past, but make a conscious effort not to dwell in the past.

Helping Others Is What We Do

Chapter 4 has been very busy since our last newsletter was published. In June we hosted a Town Hall Re-Entry session with Secretary Tucker, which was attended by many of our members and Circuit 17 staff. In August we donated card fronts to the Boynton Beach Library to assist their youth program. Our August school supply drive was a huge success and many boxes of supplies were delivered to Lauderhill Middle School. We were able to provide refreshments at three separate training sessions.

The 83rd Annual Criminal Justice Training Institute in Clearwater Beach, Florida was a great success. Chapter 4 once again received the Chapter Effectiveness Award and was very honored by having three of our nominees be selected for Distinguished Service Awards. Our Secretary Marny Lewis was the recipient of the Corrections Award. She gave a moving acceptance speech, and we are very proud of her dedication to the Department of Corrections. Captain Darin David Dowe from the Broward County Sheriff's Office was given the Law Enforcement Award posthumously, following his untimely death from cancer. His mother accepted the award on his behalf. We were glad to be able to honor his legacy, which has enhanced the law enforcement community. The Re-Entry Award was given to Thomas Lanahan

of the Broward County Sheriff's Office. He was unable to attend the conference but was later presented with the award by Marny Lewis.

In September our members stepped up to the plate when we were asked to collect toys for the Joe DiMaggio Children's Oncology Unit. In October some of our members participated in a Breast Cancer Walk and a Walk-a-Thon in support of **Domestic Violence Awareness** Month. During the month, we also collected and donated several large boxes of toiletries



for the women in the AVDA domestic violence shelter. Chapter 4 also collected cell phones in partnership with Verizon Wireless for Hopeline. October was a busy month, as in addition to our domestic violence awareness activities, ten large boxes of food were collected and donated to the Hollywood Community Church during our Operation Feeding Families Food Drive. In November we partnered with Hollywood Police and Fire and Calvary Chapel in Operation Florida Sunshine, which was a clothing drive for Hurricane Sandy victims. Also in November



we participated in the Light the Night walk for Leukemia & Lymphoma and raised hundreds of dollars for their cause. Some of our members donated toys and toiletries for Operation Christmas Child through Samaritans Purse. Our chapter board members donated cleaning supplies and toothpaste for the women that reside in The Haven, which is a domestic violence shelter in Clearwater, Florida.

Assisting domestic violence shelters is an FCCD statewide community service project this year and Chapter 4 will be making donations at each board meeting throughout the state. The other statewide project this year is raising money for the Leukemia & Lymphoma Society. We look forward to putting on our annual talent show to raise more money for this worthy organization. Our chapter is currently conducting a professional suit drive, raising toys for the Salvation Army, collecting clothing and house wares for the domestic violence shelter and selling Enjoy the City coupon books. > were presenting and kept you interested.


You certainly did not have to worry about finding something to eat! Each morning breakfast was provided and each evening there were events with great food.

banquet on the last night was the best. We had a wonderful dinner and heard about all the wonderful things




