Other community service projects our members participated in were Toys for Tots and a coat drive. One of the Chapters favorite community service events each year is the Senior Angel Tree. We contact local nursing homes and they provide a list of people that may not have family in the immediate area or enough money to provide Christmas gifts for them. Our members go all out for these "Seniors" and not only buy what is on the list but additional items too.

This past holiday season there were many news reports of identity theft, so we decided to start 2015 with training on financial crimes. Giving is Second Nature to Chapter 4 Members

Chapter 4 has continued to further our mission by assisting others in the community. We had a very busy holiday season. Our chapter was able to donate a large amount of Toys to the Salvation Army.



Our members teamed up with Chapter 8 for the Wreaths Across America project again this year. We assisted the other volunteers in placing holiday wreaths on the 11,000 gravesites of military personnel. Many people brought their children to the event so that they could earn community service hours for their schools. This was a very humbling event and we still get many phone calls from the family members of the deceased military personnel expressing their appreciation for us honoring their loved ones with a holiday wreath.



Chapter 4 sent hundreds of greeting card fronts again this year to the St. Jude's Ranch for Abused Children for their recycled card program. The donated card fronts are used by the children, who remake the cards for resale and the children get to keep the money that is raised.

We sent another large box of manufacturer's coupons to the military base in Guam to offset the grocery cost for the families of military personnel that buy their food at the base commissary.

We have been continuing to donate newspapers to the Faith Farm Ministry thrift store. The proceeds of the thrift store provide free substance abuse treatment to individuals in their program.

On January 25th our members volunteered to work the Cruizin' for Crimestoppers Motorcycle Run. The annual event raises money to pay for tips that anonymous callers receive for their assistance to the police. This year was a huge success with over 700 motorcycle riders participating. Two of our members were honored this year at the Crimestoppers Annual Awards Banquet for their help with the motorcycle run.

We conducted another large food drive for the AVDA women's shelter.

On January 27th two of our members were honored at the Leukemia and Lymphoma Awards Reception for their fundraising work to benefit Light the Night. Chapter 4 is continuing to collect bottle



caps for the Caps of Love project. The bottle caps are recycled and the money is used to buy wheelchairs for the disabled.

In conjunction with Chapter 8, we are in the process of organizing a clothing drive to benefit the Sheridan House. They operate a boy's home and a single mother's ministry. The recipients use the clothing to attend job interviews.

Chapter 4 is looking forward to attending the 86th Annual Criminal Justice Training Institute at the TradeWinds Resort on St. Pete Beach from August 24th through the 27th. We hope that many of you will be able to join us as the training is excellent and the networking is invaluable. On November 15, 2014, FCCD Chapter 7 joined the Harbor House of Central Florida and Other Agencies by participating in Harbor House of Central Florida "It Takes Courage Door Hanging Event." The goal of this event was to get the right information, to the right people, at the right time, to save lives.

Our chapter organized a team for both locations, the Valencia West Campus and UCF Campus raising Domestic Violence Awareness to the communities in Orange County. We went door to door, home by home, distributing hangers with life-saving information about Harbor House of Central Florida's 24-hour resources for domestic abuse survivors.

On November 19, 2015 we were informed of the following statistics from Harbor House of Central Florida: 571 volunteers spread out across Orlando visiting apartment complexes and housing divisions, hanging 23, 648 door hangers with the Message "It Takes Courage to Stop Abuse!" In days following the event, 46 people filed injunctions, 45 hotline calls were received by Harbor House advocates and 3 families sought safety within Harbor House of Central Florida Shelter.





Another advocate in the field of re-entry, Katherine Burns, discussed the Jacksonville Re-entry Center-The Portal of Entry (JREC). JREC is a national model and Katherine has always been on the cutting-edge when it comes to re-entry.

We believe through enhanced communication, coordination and collaboration across all stakeholders we can make our community safer by reducing recidivism, improving re-entry outcomes and assisting those who return from jail and/or prison.






