JUVENILE MENTAL HEALTH AND **SUBSTANCE ABUSE**

State President Shelley Liddle has chosen Adolescent Mental Health and Substance Abuse as her focus for this year's statewide community service project. As we do each year, we will partner with a program in the area of each board meeting and the annual training institute.

We partnered with the Bay County School District, in Panama City, at our second board meeting, February 28-29, as they have the highest rate of juvenile Baker Acts in the State of Florida. The school district requested that FCCD assist them by purchasing items that teachers can utilize with students who are showing signs of distress, to help the students better understand their stressors and help them work through them. The items, such as games, cards, coloring books, art supplies, emoji stress balls, dolls, doctor kits, books and more, will be utilized by the teachers in a program that utilizes calm corners and play therapy. Chapters and board members donated approximately \$1,350 worth of items for the Bay District School Board. Dawn A. Capes, Administrator on Special Assignment came to the meeting and provided the attendees with a brief recap of their students in need and thanked FCCD and its members for choosing their agency to support in the Bay County area.

At the May board meeting being held at The Shores Resort in Daytona Beach Shores, we will be partnering with Stewart Marchman Act Health, which is the agency that provides mental health and substance abuse programs to juveniles in Volusia County. We will be focusing on two programs; Beach House-housing for runaway juveniles and RAP-Residential Adolescent Program, specializing in substance abuse disorders.

As always, thanks for your support of FCCD and for your continued support of worthwhile causes within our communities and state.

IMPLICIT BIAS BY DJJ

Chapter 2

he Department of Juvenile Justice invited Chapter Two members to attend their Understanding Implicit Bias Workshop, on February 2, 2020. The workshop was conducted by Coordinator Minnora Bishop where she explained that bias is good and bad. Bias is described as a prejudice in favor or against one thing, person or group compared to another, usually for unfair reasons. She then described the two main types of bias; explicit (a conscious effort of bias formed from personal values and can be easily monitored and checked) and implicit (a conscious effort of bias that is based on habit and environment). Implicit

bias develops from quick thinking and shortcuts as the brain tries to filter information and fills in the blanks. Explicit bias is shaped by work, tv, media, and for many different reasons. This was followed by another activity on answering a riddle with your first thought, and your answer shows your bias. The most influential moments of 'biasness' is when people are under tremendous amounts of stress, in a cognitive-taxing environment, etc. A way to combat and prevent negative bias is to P.A.U.S.E. The workshop was well-attended and provided excellent professional development training

DOMESTIC VIOLENCE **30 MIN TRAINING** Chapter 2

During the Fifth Chapter Member Meeting, we had Vanessa Gonzalez from Refuge House come and speak for 30 minutes on domestic violence. Domestic violence is defined as "a pattern of abuse from a partner mentally, spiritually, economically, physically, or sexually, to exert power or control over someone." There are several ways we as members of the community can assist, including by listening to and believing statements and comments, asking questions, and helping the victim in finding assistance. Speaking of assistance, Refuge House provides dual services regardless of gender, age, race, income status, national origin, sexual identity or disability, which are their Housing Program and the Hotline/Therapy. The Chapter will be having an extended training with Refuge House on April 14 at Florida Commission on ffender Review.



BREAKING THE STIGMA

Chapter 6

he number of law enforcement officers who died by suicide in 2019 was more than double the number killed in the line of duty. Just let that sink in...228 officers died by suicide, while 132 officers died in the line of duty.

Departments around the country see law enforcement suicides as an ever-present challenge, including breaking through the stigma surrounding the problem.

Correctional officers are also at a high risk for depression, PTSD and suicide. Nationwide statistics reported -

- 10% of correctional officers have considered taking their own life.
- 31% of retired correctional officers have had suicidal thoughts
- 1 in 3 are dealing with PTSD
- 50% don't feel safe at work
- 33% are affected by depression

Most men don't want to ask for help because it just isn't the thing to do, also because they think they can or are handling it, No one wants the stigma of being labeled with a mental illness...it isn't something you just bring up. You drink, you go hang out with your buddies and that is how you deal with it.

The strongest thing someone can do is ask for help...coming forward is going to have a tremendous impact on stigma reduction and awareness. When it's hidden, you don't know the scope of the problem and



it's not being taken seriously. "You smash the stigma, vou save lives," - Jon Adler, Director of the Bureau of Justice Assistance at the Department of Justice and former Police Officer.

After the latest suicide in New York, NYPD Commissioner James O'Neil reminded officers that there is help available, in a message that resonated around the country.

"To every member of the NYPD, please know this: it is okay to feel vulnerable. It is okay if you are facing struggles," O'Neill said. "And it is

okay to seek help from others. You may not know this, and it may be hard to imagine, but you are not out there all by yourself. More people than you know, who wear the same uniform as you do, share the same doubts and fears and strug-

gles that you do."

"Seeking help is strength," he added. "Talking about your problems is strength. Acknowledging you need a place to turn is strength. There is no shame here only a promise to provide you with the help and support you need and deserve."

In the coming months, FCCD Chapter 6 will be conducting training events addressing Mental Health and Suicide Awareness. The training will be relevant to all ages and all walks of life, not just Criminal Justice Professionals. FCCD Chapter 6 serves the citizens of Escambia, Santa Rosa, Okaloosa and Walton Counties. You are invited to come be a member of our local Chapter. You are also invited to come and train with us in the Panhandle.





Sure enough, it did grow back and when he saw her at Easter this year (2019), we told the story to him, he laughed because now his hair is long and he has no desire to cut his hair! Now I want him to cut it! In May 2014, I am now back at the Cocoa Office. Patricia, Nichola and Tynassia decided to re-establish FCCD (Florida Council on Crime and Delinquency) It's a Non Profit Organization consisting of Law Enforcement and other organizations involved in the Criminal Justice System reaching out to the Community thru Community Service Projects. Patricia would be the President. Nichola shared with me after the meeting about FCCD. I was not interested. But I listened to Nichola and agreed to go to the meeting because of her and Patricia! Nichola, had no idea that Patricia and I were friends, nor did Patricia know that Nichola and I were friends! I told Nichola, you tell Patricia, I will come and you watch Patricia will smile. Sure enough that is what happened, she smiled! I joined FCCD after the meeting! Tynessia tells the story very well! We laugh everytime! The Lord had a great plan, and thru FCCD our friendship blossomed even more!

We served the Lord in the Community thru FCCD participating in CS Projects such: as VA Stand down, Breast Cancer Walks, Juvenile Diabetes Walk, gifts at Christmas for Crosswind Teenagers and in the summer serving on Friday nights at the SPOT cooking for the teenager and families while they played basketball with the Real Church Charlette Perkins and Jarvis Wash). Then we went to the Board Meetings and hanged out meeting prominent people with the DOC, and we were just probation officers. We had a lot of fun and laughs! I remember one evening we were driving up and down Daytona Beach in Barbies White Mustang, like a bunch of teenagers whooping and hollering! At another meeting when I was trying to sleep, Nichola and Patricia would be up talking way late, and I was trying to sleep, I actually had to put a pillow over my head, and they just laugh! Since Feb. 2019, I was able to spend time with Patricia while she was in the rehab. It was my time to serve her, and I am grateful I had the time and opportunity. Our friendship went to a deeper level and now it bloomed! Color did not matter in our friendship and now her family is very special to me! She was still smiling and laughing even though she was in a tough situation. She did not give up. She is a fighter with faith. On my last visit with her: she, her mom, and Uncle Joe picked my outfits out for my 40th HS Reunion. I wore the clothes they picked out! We laughed again!

I will carry my memories in my heart, and I would encourage you all to do as well. Laugh, smile, and love unconditionally to your friends and family. Be the smile of God!
