

resident Alice B. Sims has picked her theme for 2022-2023 as "Celebrate, Honor and Respect Families"; her motto is "Leaving a Family Legacy", and her community service project is with two organizations, Florida Alliance of Boys and Girls Clubs and Prodigy Cultural Arts Program. As FCCD had a ZOOM meeting for the first board meeting, the plan was to offer a choice for chapters to pick either organization for their project and then we focus on one organization at the February and May Board meetings and both organizations at the conference. However, with the arrival of Hurricane lan in September, the board changed the focus for the November 2022 project, and we focused on hurricane relief efforts. The February Board meeting will focus on Florida Alliance of Boys and Girls Clubs, the May Board meeting will focus on the Prodigy Culture Arts Program and both organizations will be the recipients of donations at the annual training institute.

For the Hurricane Ian Relief Effort, we asked chapters to collect non-perishable items, cleaning supplies, pet supplies, etc. We were advised that many Department of Corrections and Department of Juvenile Justice employees, had damage from Hurricane lan, ranging from devasting (lost everything) to minor. Our focus was to assist those within our organizations affected by this disaster. FCCD offered, "Adopt a Family" as an option, for chapters and/or members to adopt a family that was affected by the hurricane with all items collected going directly to the identified family. We do not have the totals of what was collected as of this article, but we can advise that a number of truckloads of supplies were delivered to DeSoto CI and Charlotte CI employees. Some chapters also purchased gift cards which were given to families affected by the storm, to assist them in purchasing needed supplies. Additionally, members donated to relief efforts of local restaurants employee assistance programs to assist employees who not only lost their incomes due to closure of their employer, but also suffered damages during the disaster.

At the board meeting in February in Jacksonville, we will be partnering with the Florida Alliance of Boys and Girls Clubs, an organization located in Tallahassee, which works to secure statewide funding and resources for local Boys and Girls Clubs throughout the State of Florida. Chapters have three choices on how to participate:

- 1. Collect money which will go towards scholarships for local BGC youth, who would be the first in their family, to attend college (the Florida Alliance Group will match donations made by FCCD)
- 2. New books for middle school aged youth
- 3. New sports equipment for middle school aged youth

Information will be provided in the next Councilor on the items for the Prodigy Cultural Program.



> had in over 30 years.




assists teenage girls who are pregnant or have a small child. They provide housing and assistance to the teens, which allows them to
