FCCD is a non-profit corporation dedicated to the promotion of high professional standards for criminal justice agencies and criminal justice personnel.

The mission of the Florida Council on Crime and Delinquency is to foster interagency collaboration of all criminal justice entities, provide relevant training, and encourage community service throughout the State of Florida.

FCCD's history dates back to 1935 through an antecedent organization, the Florida Probation Association. The council was chartered by the Secretary of State in 1964 as a non-profit corporation dedicated to promoting high standards for criminal justice agencies and criminal justice personnel.

The Board is composed of the State President, State President-Elect, State Treasurer, State Secretary, Immediate Past President, Executive Director, Executive Secretary, and Administrative Assistant

Chapters

FCCD is divided into 35 chapters across the State of Florida, with a total statewide membership at over 3,000.



Our membership boasts a particularly diversified populace, including state and private correctional staff, police, probation and parole staff, deputy sheriffs, DJJ staff, state attorneys, public defenders, private attorneys, judges, county and private jail staff, and concerned citizens.

Annual Training Institute

Each year FCCD holds an Annual Criminal Justice Training Institute over the course of three days. The purpose of the Institute is to provide our members with high-quality training in the field of criminal justice. In recent years, participation at the Institute has increased to over 500 members. At the training Institute individuals who have gone above and beyond in their efforts to make Florida a safer place are awarded a Distinguished Service Award. These awards are in the field of Corrections, Criminal Justice, Judicial, Juvenile Justice and Law Enforcement. Also, presented are several college scholarships. During the Institute, we hold our annual business meeting to elect officers for the coming year, conduct necessary business, establish policies for the organization and consider resolutions on issues relating to Florida's criminal justice system.
